The book examines the relations among the state, the Church, Coptic citizenry, and civil and political societies against the backdrop of the increasing diversification of actors, the change of political leadership in the country, and the transformations occurring in the region. This book examines the Brotherhood's visions and practices, from its inception in 1928, up to its response to the 2011 uprising, as it moves to redefine democracy along Islamic lines. The book relies on dozens of interviews with members of the Muslim Brotherhood, not only on a leadership level but also among the rank and file and engages with hundreds of original and unique first hand sources as well as secondary sources with a view to understanding the movement's political thought. The book analyses the Muslim Brotherhood's position on key issues such as on the nature of the state, gender, political pluralism and religious minorities. The book provides foresight on governance conundrums which the Muslim Brothers would face which proved to be well placed
