### OVERVIEW

Santiago Ripoll is a social anthropologist specialised in food security, health and nutrition. He uses ethnographic and participatory approaches to individual and behavioural change in health, food and nutrition systems and in the context of humanitarian emergencies. He holds a PHD in Social Anthropology, an MPhil in Development Studies and studied Veterinary Medicine as an undergraduate. He has applied a social science lens within trans- and inter-disciplinary research processes to influence policy and practice in humanitarian health emergencies and in public policy debates around food and agriculture. Much of his recent work is around health-seeking and vaccination practices in health emergencies and how those are shaped by social context and moral frameworks. He has experience conducting doing quantitative research (conducting and commissioning household surveys) and qualitative research (participatory research, ethnography, life stories, interviews, etc.). He is the Director of the Sussex University Social Science and Ethics Research Group (SSERG).
