# <u>Summary</u>

My research interest has been concerned mainly with low carbon development and climate change policy in China, and its growing impact in global climate change regime and international cooperation on green technology and services. As a political economist I am working mainly on inter-disciplinary issues around China's low carbon energy transition and environmental sustainability. My current research focus on the impact of climate change and environmental policies on the most vulnerable social groups and communities in quasi-urban and urban contexts. I seek to investigate the complex relations between environmental hazards, social inequalities, and political processes at local, national and global level, which leads to new configuration of power relations between state and market, and between central and local actors.
