Dr Keetie Roelen is a Senior Research Fellow at the Centre for the Study of Global Development (CSGD) at the Open University, UK. She previously held positions at the Institute of Development Studies (IDS), UK and Maastricht University, Netherlands. Keetie is an Honorary Associate of IDS and Affiliated Researcher of the Global Research Programme on Inequality (GRIP) at University of Bergen, Norway. She holds 18 years' experience in research, teaching, and policy advice in global development. She is a recognised expert in areas of poverty, social protection, and anti-poverty interventions in relation to children, women, and psychosocial wellbeing. She has worked with many international organisations such as UNICEF, World Bank, Save the Children and Concern Worldwide, performing research and policy advice work in Southern and Eastem Africa, Asia, Central and Eastern Europe and Haiti. Dr Roelen has secured £2+ million in external funding and has successfully led a range of large-scale multi-partner projects, including the prestigious ESRC Future Leaders grant and a GCRF ECD project funded through the British Academy. She has quantitative and qualitative research skills with a strong interest in combining methods to gain deep understanding in complex issues of development. Dr Roelen is a highly experienced teacher and trainer, having developed and led courses for postgraduate students, professionals, and policy makers in a wide range of settings. Her work has been extensively published in the form of high-quality journal publications, book chapters, working papers and policy-oriented publications.
