# **OVERVIEW**

I am a researcher who has worked across the disciplines of geography and international development since 2007. I am currently a Fellow in the Participation Inclusion, and Social Change cluster at IDS. I have worked for both research institutes and non-government organisations in both Europe and Africa. I completed my doctorate at the Technological University Dublin in collaboration with University KwaZulu Natal, as an African Vision Research Institute Scholar, focusing on the social and economic impact of visual impairment in Mozambique. My current research mainly focuses on the themes of social justice and inclusion. I am particularly interested in using participatory methods to develop understandings of disability inclusion in low-income contexts, inclusive higher education and sustainable development. Recent research has involved working with a consortium of partners of non-government organisations and organisations of people with disability on the Disability Inclusive Development Programme. I am currently the Principal Investigator of the Disability Inclusive Sustainable Global Development Network Coordination. I have completed research consultancies for various aid agencies including those belonging to the UK, Irish, Swiss, Australian, and Norwegian governments, as well as for the WHO, UNICEF, the European Commission, and various non-government organisations. My research has been cited 382 times. My h-index score is 11 and my i10 index is 14. I am also a Fellow of the Higher Education Academy and I hold a Post Graduate Certificate in Higher Education. I am the Course Convenor for the Masters in Development Studies and I teach on various modules including Ideas in Development, Debating Poverty and Vulnerability, Foundations of Power, Participation and Social Change, and Research Design. I have also delivered guest lectures about development at the University of Brighton for the Global Social Policy module. I am the School Research Ethics Officer for IDS and also the Investigating Officer for Academic Misconduct. I sit on the Editorial Steering Committee for The Bulletin journal. I have peer reviewed research for various journals including the International Journal of Migration, Health and Social Care, the Journal of International Development, European Journal of Development Research and Asian Development Review. I previously served as a Trustee on the Board of the non-government organisation Vision Action, for whom I also previously worked as a project manager. I also previously worked for a coalition called the Mozambique Eyecare Project and was based at Lurio University in Mozambique.
