OVERVIEW

I'm a researcher currently working for IDS within the 'Business, Markets and the State' research cluster. I also support the UK's Department for International Development (DFID) and Foreign and Commonwealth Office (FCO) through the 'K4D programme' – i.e. in order to improve the impact of development policy and programming with the use of evidence. I have an interest in broad areas of development research, my main areas of expertise being – development finance, taxation and private sector development (e.g. employment, firm productivity, markets, etc.) in developing countries. Previously, I worked as an independent consultant (e.g. Overseas Development Institute (ODI)) and as a researcher for the Belgian Policy Research Group on Financing for Development (BeFinD) at the University of Namur. As an independent consultant, for instance, I assisted ODI and the Centre for Tax Analysis in Developing Countries (TAXDEV) of Institute for Fiscal Studies (IFS) in selecting partner countries for the TAXDEV II project. At BeFinD, I provided research-based policy support for the development ministry of Belgium – assisting policymakers both in Belgium and in partner Sub-Saharan African countries. Part of my role was to conduct research on the Value-Added Tax to facilitate reforms in Belgium's partner countries (mainly, in Africa). The objective was to improve Domestic Resource Mobilization in partner countries. Apart from conducting research and providing policy advice, I was also involved in the management of the BeFinD research group.
