The Youth Employment and Politics webinar series is linked to IDS' strategic research initiative: 'Ensuring decent work and political inclusion for young people', which is part of the 2020-25 IDS Strategy.

IDS research undertaken within this strategic initiative contributes to new thinking on youth engagement and the links between youth employment and citizenship, including in fragile and conflict-affected settings. The webinar series will focus the themes of youth mobility, employment, rural livelihoods, politics, peace and security, and youth in humanitarian settings. The speakers will address both the 'histories' and 'futures' of youth by speaking to dynamics before and during the pandemic and making observations on its implication.

Presentations will primarily focus on sub-Sahara Africa and the Middle East and North Africa (MENA) region. In line with our values on inclusiveness of voices and co-construction of knowledge, the webinar series will capture diverse perspectives. Speakers and discussants represent academia, civil society, governments and UN agencies. Researchers involved in the IDS Europe Engagement Initiative will also share insights. Together we aim to strengthen development thinking and practice for more effective interventions for 'the Covid generation' to tackle what is a universal development challenge.

We invite researchers, policy actors and civil society representatives that study, fund and implement youth policies and programmes to sign up for our webinars and join the debate.

## Chair Dr Marjoke Oosterom – Institute of Development Studies



Marjoke Oosterom is a research fellow in the Power and Popular research cluster at IDS. She holds a PhD from IDS and has a background in comparative politics and development studies. Her research concentrates on how experiences of violence and conflict affect forms of agency, citizenship, and everyday politics and governance. Her specific expertise is on youth politics and youth agency in response to insecurity and violence, and politics in the informal economy. She has been involved in consultancy work for policy makers and international NGOs that fund and implement governance and youth-focused interventions in fragile and conflict affected

settings. Marjoke leads IDS' strategic research initiative on youth employment and politics, and is convening this webinar series.

#### Dr Louise Fox – Brookings Institute



Louise Fox is an experienced development economist who specializes in strategies for employment creation, opportunity expansion, economic empowerment, and poverty reduction. She has advised governments in the developed and developing world, international organizations, and philanthropic and non-profit organizations on problem diagnosis, strategies for results, and outcome measurement. She held full-time positions at USAID (as Chief Economist) and at the World Bank. She is currently affiliated with the African Growth Initiative at the Brookings Institution and the Blum Center for Developing Economies, University of California,

Berkeley. She was previously affiliated with the Overseas Development Institute, where she led a major research project on Gender and Agricultural Transformation. Louise has published in the areas of inclusive growth, structural transformation, youth employment, the political economy of poverty reduction, gender and women's economic empowerment, employment, labor markets, and labor regulation, pension reform, reform of child welfare systems, social protection, effective public expenditures in the social sectors, and female-headed households and child welfare. Her most recent book was Youth Employment in Sub-Saharan Africa, published by the World Bank in 2014.



### **Discussants**Dr Azita Berar Awad - Graduate Institute of International and Development Studies



Azita Berar Awad, is an internationally renowned political economist and global policy advisor on inclusive social and economic policies with extensive experience in international development cooperation and in the United Nations system. She has held several senior leadership positions at International Labour Organization (ILO) including as Director of the Employment Policy Department from 2006 to 2017.

She has advised senior policy makers across all regions and supported institutions of governance at national and global levels on comprehensive policies promoting full and decent employment and gender- inclusive sustainable development.

In the wake of the 2008/09 global financial crisis, she led ILO's strategy and the 2012 international Call for Action on the youth employment crisis, She has also led the UN system's joint response to the emerging global youth employment crisis including with the foundation and launch in 2016 of **the Global Initiative on Decent Jobs for Youth,** an inclusive multi-stakeholder partnership of governments, social partners, private sector, foundations, civil society including youth organizations and academia, established under the 2030 Sustainable Development Agenda. In 2020, she founded the first **Global Interdisciplinary Policy Research Network of academia and policy actors on Youth Transitions.** The Global Network brings together policy researchers and think tanks from some 30 universities in the Global North and the Global South interacting with policy actors on policies on priority issues for youth transitions and policies.

Azita Berar has facilitated numerous international tripartite negotiations leading to the adoption of new international standards. She has directed research and policy reports in several fields of proemployment macro-economic policies, poverty reduction strategies, gender equality, youth employment, informal economy; economic and social policies for peace-building and disaster resilience and is the author of numerous publications.

Currently Director of Policy at the Global Labour Organization (GLO), she is also a Senior Fellow at the Graduate Institute of International and Development Studies in Geneva and teaches in various universities and executive education programmes.
