# Youth politics: what to make of youth voices through the pandemic

Accompanying resources April 2021



The Youth Employment and Politics webinar series is linked to IDS' strategic research initiative: 'Ensuring decent work and political inclusion for young people', which is part of the 2020-25 IDS Strategy.

IDS research undertaken within this strategic initiative contributes to new thinking on youth engagement and the links between youth employment and citizenship, including in fragile and conflict-affected settings. The webinar series will focus the themes of youth mobility, employment, rural livelihoods, politics, peace and security, and youth in humanitarian settings. The speakers will address both the 'histories' and 'futures' of youth by speaking to dynamics before and during the pandemic and making observations on its implication.

Presentations will primarily focus on sub-Sahara Africa and the Middle East and North Africa (MENA) region. In line with our values on inclusiveness of voices and co-construction of knowledge, the webinar series will capture diverse perspectives. Speakers and discussants represent academia, civil society, governments and UN agencies. Researchers involved in the IDS Europe Engagement Initiative will also share insights. Together we aim to strengthen development thinking and practice for more effective interventions for 'the Covid generation' to tackle what is a universal development challenge.

This webinar focused on young people's civic and political action before and during the pandemic, connecting this to debates on civic space. In various countries, lockdowns were accompanied by state violence.

We invite researchers, policy actors and civil society representatives that study, fund and implement youth policies and programmes to sign up for our webinars and join the debate.

# Chair

### **Dr Dorte Thorsen - Institute of Development Studies**



Dorte Thorsen has done research with adolescent and youth migrants since 2005, primarily in West Africa. Over four years she did multi-sited fieldwork following fifteen migrants between village, capital and neighboring Côte d'Ivoire, becoming familiar with the normality of West African mobilities and the social relations at work in the urban informal economy. Her main focus now is on how social change, gender and generational dynamics and mobility are entwined. Policy-wise her work speaks to discourses around young migrants and their work, criticising simplified notions of trafficking and

child labour – important in this year designated by the UN to focus on the elimination of child labour – and to discourses around youth and decent work, trying to highlight ongoing social change as an important element of understanding how gender norms and values affect young people's lives.

Marjoke Oosterom is a research fellow in the Power and Popular research cluster at IDS. She holds a PhD from IDS and has a background in comparative politics and development studies. Her research concentrates on how experiences of violence and conflict affect forms of agency, citizenship, and everyday politics and governance. Her specific expertise is on youth politics and youth agency in response to insecurity and violence, and politics in the informal economy. ## Professor Emma Murphy – Durham University



Emma is a professor of political economy at Durham University. Past research evolved from a focus on structural aspects of economic and political liberalisation in the Middle East and North Africa, to broader processes which connected the region to the developing global political economy. Most recently she has been working on MENA youth in the contemporary global political economy, working on international and interdisciplinary collaborations which engage in cross-regional comparative research and deploy a range of quantitative and qualitative methods. She is currently a Co-I on a GCRF project studying young women's experiences of

using and working in the transport sector in Africa through anthropological methods, and a Co-I on a survey project assessing the experiences of young people living under lockdown in the North East of England.

### Dr Daniel Agbiboa – Harvard University



Daniel E. Agbiboa is Assistant Professor of African and African American Studies at Harvard University, where he also holds the position of Faculty Associate of the Weatherhead Center for International Affairs and Executive Committee Member of the Harvard Mellon Urban Initiative. He holds a PhD in International Development from the University of Oxford and an MPhil in International Development from the University of Cambridge. His research interests center on the relations between governments and

publics in contemporary Africa. He is the author of *Transport, Transgression and Politics in African Cities: The Rhythm of Chaos*, and of several articles in leading journals, including *African Affairs, African Studies Review, International Journal of Urban and Regional Research, and Journal of Peacebuilding and Development*.
